What would the estimated balance be after 12 months based on a range of deposits?	<p>If you saved £50,000 the estimated balance after 12 months would be £50,125.00.</p> <p>If you saved £1,000 the estimated balance after 12 months would be £1,001.00.</p> <p>These examples assume that the account is opened with the amount stated on 01 April, no withdrawals or further deposits are made throughout the 12 months, the interest earned is added to the account, and no changes are made to the current interest rate. How do I open and manage my account?	<p>This account is available to UK residents and can be opened and operated at a branch.</p> <p>Joint accounts are allowed.</p> <p>The minimum balance to open the account is £25. The maximum balance per account is £250,000 for accounts held in sole name or £500,000 for accounts held in joint names.</p> <p>Additional deposits can be made at any time up to the maximum allowed.</p> <p>Payments into the account can be made in cash, by cheque or debit card (up to £1,000). You can also pay in by electronic payment (but not direct debit) or standing order.</p> <p>We accept savings applications from existing members across the UK and new members in the following postcode areas: BB, BD, BL, CA, CH, CW, FY, LA, M, OL, PR, SK, WA, WN.</p>				
Can I withdraw money?	<p>You can withdraw from your account whenever you need in branch. Limits apply on cash withdrawals.</p> <p>You can close the account at any time if you need to.</p>				
Additional information	<p>*Interest will be paid gross. This means all the interest we pay you will be without tax deducted. If the total amount of interest you receive exceeds any Personal Savings Allowance to which you're entitled, you may have to pay tax at the applicable rate. This would need to be paid directly to HM Revenue &amp; Customs. ## Additional Terms and Conditions applicable to Branch Saver

### 1. What terms apply?

These Conditions must be read in conjunction with the Society's General Savings Account Terms and Conditions.

### 2. Membership

This account is a share account which confers membership rights and is subject to the Rules of the Society. Copies of the Rules can be obtained from our website or any branch.

### 3. Eligibility

- 3.1 You must be a UK resident. It is not available to sole traders, partnerships, companies, associations (whether incorporated or not) or any kind of business, club or charity.
- 3.2 Evidence of personal identity and address identity will be required before the account is opened.
- 3.3 The minimum opening balance for a Branch Saver is £25.
- 3.4 A Branch Saver can be opened and operated by visiting a Marsden branch with your account passbook.
- 3.5 This account is available to UK residents.
- 3.6 We accept savings applications from existing members across the UK and new members in the following postcode areas: BB, BD, BL, CA, CH, CW, FY, LA, M, OL, PR, SK, WA, WN.

### 4. Payments In

- 4.1 Payments into the account can be made in cash, by cheque or debit card (up to £1,000). You can also pay in by electronic payment (but not direct debit) or standing order.
- 4.2 Investments are limited in that they may not increase the account balance above £250,000 for accounts held in sole name or £500,000 for accounts held in joint names.

### 5. Withdrawals

- 5.1 Withdrawals from your account can be made in cash, by cheque or internal transfer. Transfers to your bank account are permitted up to a limit of £1,000 per week subject to satisfactory evidence of your nominated bank account.
- 5.2 Withdrawals are permitted on demand. Limits apply on cash withdrawals.

### 6. Interest and payment of Interest

- 6.1 Interest rates are variable.
- 6.2 Interest is earned daily and will be paid annually on 31 March.
- 6.3 Interest can be paid to this account, transferred internally to another suitable Marsden Building Society account, or transferred externally to another UK bank/building society account.
- 6.4 Statements are not issued automatically for this account. Instead, your passbook is your record of transactions. Your passbook will be updated following any transaction carried out at branch or at your request.
